# The Hang Seng University of Hong Kong – Foundation 香港恒生大學－基金

The Hang Seng University of Hong Kong – Foundation is established by The Hang Seng University of Hong Kong (HSUHK) to serve as a platform to engage our donors, connecting them to the advancement of its teaching, learning, and research priorities. Embracing the unique “Liberal + Professional” education model, HSUHK aspires to excel as a leading private liberal-arts-oriented university in the region.

In 1980, Hang Seng School of Commerce (HSSC) was established with funding from the S H Ho Foundation, the Ho Tim Charitable Foundation, Dah Chong Hong Limited, several Hang Seng Bank founding directors, and Hang Seng Bank Limited. From 1980 to 2009, HSSC was a pioneering and leading provider of post-secondary programmes in business and related areas.

In response to the Chief Executive’s Policy Address in 2009 which highlighted the growing significance of quality private universities in Hong Kong, HSSC, in 2010, was re-structured into Hang Seng Management College (HSMC), a non-profit private university-level institution registered under the Post Secondary Colleges Ordinance (Cap. 320) to offer bachelor’s or higher degree programmes in diversified disciplines.

8 years later, on 30 October 2018, HSMC was granted approval by the Government of the Hong Kong Special Administrative Region (HKSAR) to gain university title as “The Hang Seng University of Hong Kong”.

HSUHK aspires to be a leading, non-profit, private liberal-arts-oriented university in the region, recognised for its excellence in teaching, learning, and research, serving and advancing our society and the world. HSUHK has 5 Schools (Business, Communication, Decision Sciences, Humanities & Social Science, and Translation) with a student population of around 5,000 and 200 full-time academic staff members.

HSUHK currently offers a number of bachelor’s (Honours) and master’s degree programmes. Many of these programmes are unique and the first of its kind in the region. All programmes were accredited by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications and recognised by the Governments of HKSAR, mainland China, and Taiwan.

Playing a unique and substantial role in the higher education sector in Hong Kong and in the region, HSUHK is cultivating transferable core competencies in our students. The University is characterised by small class teaching, very close student-teacher interactions, mentorship for individual students outside classrooms, dynamic learning environment, residential college experience, and vast opportunities for internship, international exchange and independent research. The University puts quality teaching and students’ all-round development as its highest priorities, aiming at nurturing young talents with critical thinking, innovative minds, caring attitude, moral values and social responsibilities.

香港恒生大學－基金由香港恒生大學（恒大）創立，旨在凝聚所有捐贈者的力量，藉以推動恒大教學與研究發展，貫徹本校獨有的「博雅＋專業」教育模式，致力成為區內具領導地位並以博雅教育為主導的私立大學。

1980年何善衡慈善基金會、何添慈善基金會、大昌貿易行、若干恒生銀行創辦人及恒生銀行慷慨捐資成立恒生商學書院（恒商）。從1980至2009年，恒商的文憑與副學士學位課程在學界及商界甚具口碑，成績斐然。

香港行政長官於2009年度的施政報告指出，優良的私立大學在香港日趨重要。有見及此，恒商於2010年改組成恒生管理學院（恒管），根據《專上學院條例》（第320章）註冊成為非牟利私立專上學院，提供多元化本科及以上程度的學位課程。

8年後，恒管正式獲香港特區政府於2018年10月30日批准，正名為「香港恒生大學」。

恒大矢志成為區內具領導地位、非牟利並以博雅教育為主導的私立大學；並透過卓越的教學、研究及服務，推動社會與世界發展。恒大由5個學院組成（商學院、傳播學院、決策科學學院、人文社會科學學院和翻譯學院），現有約5,000名全日制學生及約200名全職教學人員。

恒大現提供多個榮譽學士及碩士學位課程，部份課程為全港首創。所有課程均獲香港學術及職業資歷評審局審批認可，並獲香港、中國和台灣政府承認。

恒大在香港高等教育界和區內扮演著一個獨特和重要的角色，為學生建立可轉移的核心能力。其特色為小班教學、緊密的師生關係、課堂外對個別學生的關顧指導、動態學習環境、住宿書院體驗，及廣泛的實習、國際交流和獨立研究機會。恒大把優質教學和學生個人全方位發展訂為最優先目標，以培育青年人成為具明辨思維、創新思考、人文關懷、道德價值及社會責任感的人才。





## Leadership and Objective 領導架構及基金目標

The Foundation reports to the HSUHK Board of Governors and is managed by the Foundation Management Committee. With a view to deepening connection with members of the corporate community, individuals, and alumni, the Committee is charged with the duties to ensure safe custody of and decide usage of the funds of the Foundation.
